
Unlimited users can be added in system.

Vouchers

- Facility to import voucher from excel file, multiple vouchers can be created from a single excel file.
- Vouchers can be schedule for future and can also be scheduled to be reverse in future i.e. Rent Voucher, EMI Voucher or any fixed entry which occurs after a certain duration.
- All vouchers are linked with smart scan through Unique Id. So just put your bills at scan machine and smart scan will scan/read document and will attach it automatically with voucher.
- Transaction based voucher entry so that you get every possible report from ERP.
- Linked with webtel GST software for filing returns.
- User can create duplicate voucher with a single click.

Vouchers

- in case authorising person rejects voucher then he can put his comments in vouchers and users can make correction in vouchers accordingly.
- User can attach supporting documents with vouchers i.e. scan copy of invoice or any other file.
- Every transaction is linked with ledgers which helps you to drill down details of ledgers (All ledgers of balance sheet and P&L) with following details
 - Name of party who have raised invoice or name of employee who claimed expenses.
 - Invoice/document # of invoice/bill.
 - Invoice date
 - Amount
 - Above details are available for all ledgers.

Book-keeping

- ► All your records get digitized and linked with voucher.
- Copy of bills are automatically linked with all related vouchers with following steps.
 - ► Any office support staff will put copy of bills in scanning machine.
 - Smart scan will scan whole file as pdf and read voucher.
 - > Automatically upload that scan copy of bills with voucher.
 - Once bills are uploaded in ERP, users can see uploaded documents from user account.
- No requirement for asking for physical copy for bills/documents in future and can be accessed after 5-10 years with just a single click.
- All your transactions are linked with copy of bills so it bring full transparency in your accounting system and makes it very easy to detect any problem and financials.
- Complete paperless auditing can be done as all required vouchers are available in ERP.
- Physical documents can be kept in safe place.
- Paid Feature)You can create your own google for all your scanned record with following feature.
 - > System automatically reads all contents of scanned documents.
 - You can search any text in scanned documents from past. i.e. if you have a hotel bill or any document which was submitted 5 year ago and if you search the hotel name, you will get the copy of hotel bill which was was submitted 5 year ago.
